Message from the Board Chairman and our President

Since our start in 1954, the Child Guidance Center of Southern Connecticut (CGC) has provided mental health services to children and teens in our surrounding communities, regardless of their families' ability to pay. While the words in our mission, the programs we provide, and the challenges we face have evolved through the years, our intentions have never wavered. With help from CGC friends like you, we continue to ensure that services are accessible to children and families in critical need of support.

In the face of declining government and foundation funding, the incidence of children's mental health problems has never been higher. One in five children has a mental health condition and at least 80% of these children go without treatment. Half of all mental illness emerges before the age of 14, and the lifetime economic cost is greater for mental illness than for any other non-communicable disease. Given the staggering emotional and economic costs of mental illness, declining funding is nothing short of a public health crisis. The result of inadequate funding for mental health care can be dire, as suicide is now the second leading cause of death for those ages 10 to 34 years old.

While the decrease in funding poses a significant challenge, it also further motivates our staff to develop and implement solutions that will reach more children and families in need. With funding from a local family foundation, for example, next year we will be opening a walk-in clinic at our West Broad Street office to enable parents to bring their child for an evaluation the same day they call. We plan to grow our medication evaluation and management services, and to expand the range of evidence-based individual and group treatments for a variety of mental health conditions. CGC continues to witness an increased need for children's mental health services in our community and we are ready to meet this need.

Though we receive funding from the State of Connecticut and fees from Medicaid and private insurance companies, this support covers less than 70% of the total cost of providing mental health services. Your contributions make it possible for CGC to continue to provide high quality services for children who are in dire need of mental health care.

Thank you for your continued support of our community's most vulnerable children and families.





PROGRAMS & SERVICES

Using a child-centered, family-focused approach, our programs serve children struggling with a range of challenges, such as depression, anxiety, and developmental delays. We are committed to enhancing access to evidence-based treatments in our communities.

Crisis services target children at the highest risk for injury, abuse, or trauma:

- **Mobile Crisis Intervention Services** are provided 365 days a year to stabilize critical situations and prevent suicide, violence, and dangerous behaviors;
- Child Advocacy Center provides a child-friendly environment where child victims of physical abuse, sexual abuse, and neglect are interviewed for forensic purposes and are connected with mental health, advocacy and medical services.

Specialized treatment programs target children of certain age groups and diagnostic categories to foster healthy development:

- Child and Family Therapy provides a range of clinic-based assessment and treatment services (ages 3-18);
- Multi-Dimensional Family Therapy offers intensive, in-home child and parent treatment for youth abusing alcohol or drugs and engaging in delinquent or dangerous behaviors (ages 9-18);
- Child First offers intensive, in-home parent/child therapy and care coordination focused on decreasing the harmful effects of trauma and deprivation on early development (ages prenatal-6).

Additionally, we offer services that further ensure the stability of children and teens:

- System of Care helps families with complex needs access integrated services;
- Developmental Evaluations and Psychological and Neurological Assessments help identify and design a plan to address developmental, learning and neuropsychological concerns;
- **Community Emergency Response** offers on-site counseling for emergencies impacting large groups in the community, including natural disasters, suicides and school violence;
- **Preventative Services** such as community education workshops and consultation services to schools and child-serving agencies, advance best practices in the field of children's mental health.

OUR IMPACT

CGC clinicians are all specially trained to treat children and teens struggling with various types and intensity levels of mental and behavioral health issues. Like Jasmine*, who at 5 years old came to us due to behavioral issues at home and in the classroom; or Leo*, a 13 year old boy who struggled with depression that led him to withdraw from family and friends; or Cassidy*, a teen who struggled with suicidal thoughts. No matter the issue, our staff of qualified mental health professionals help children and families from all walks of life overcome and manage their challenging circumstances.

Meet Michael

Michael*, at 17 years old, had a history of severe physical abuse and neglect. While some children develop and demonstrate extraordinary resilience in the aftermath of these experiences, many, like Michael, struggle with significant distress or develop psychological difficulties that can be serious or long-lasting. After being released from a psychiatric hospital due to experiencing suicidal thoughts, he was referred to CGC.

Knowing that Michael had a history of ending treatment prematurely with other mental health agencies, he was offered a trauma informed treatment which is an effective intervention for children who have significant psychological symptoms following abuse or neglect.

During 10 months of treatment, Michael had no instances of suicidal thinking that necessitated hospitalization or crisis services, and he consistently attended his treatment sessions at CGC. Whenever he started to think about suicide, he'd put into practice the safety plan he and his clinician agreed to. Michael worked hard to improve his relationships with family members and school staff and, as a result, now has a better support system.
